

Admission Requirements

Apply to Reedley College and join our thriving and diversified student body. To determine whether you are eligible for admission to Reedley College (Students must be at least 18 years old by the start of the semester to be accepted), please complete the **Admissions Checklist** and return it along with the following documents:

- 1. ADMISSIONS APPLICATION
- 2. SIGNED AFFIDAVIT OF SUPPORT
- 3. FINANCIAL VERIFICATION FROM SPONSOR'S FINANCIAL INSTITUTION (Letter from your sponsor's bank or bank statement)
- 4. SIGNED COST OF ATTENDANCE ACKNOWLEDGEMENT
- 5. HIGH SCHOOL TRANSCRIPTS (may be emailed with other documents)
- 6. TRANSFER ELIGIBILITY FORM FOR TRANSFER STUDENTS WHO ATTENDED ANOTHER COLLEGE OR UNIVERSITY
- 7. TEST OF ENGLISH FOREIGN LANGUAGE (TOEFL), INTERNATIONAL ENGLISH LANGUAGE TESTING SYSTEM (IELTS); DUOLINGO; OTHER TESTS MAY BE ACCEPTED ON A CASE-BY-CASE BASIS
- 8. COPY OF PASSPORT

DEADLINES: June 1st for Fall Semester (Begins in early August).

November 1st for Spring Semester (Begins in early January).

How to apply online:

- Go to <u>www.reedleycollege.edu</u> and click on **Apply Now** at the top right-hand side of the screen. Next, choose **New Student** and then **Create an account** under Step 1 on the next page.
- You will be asked to create a CCCID (California Community College Identification) account with your profile, including a user name and a password. Be sure to save your username and password as the application system is separate from the college.

We require the following documents:

School Records:

Official transcripts/certificates and evidence of graduation from a secondary school or its equivalent are required. Please mail records in your language and in English. If your records are not in English, certified translation must be furnished.

• TOEFL Score Requirement:

A TOEFL (Test of English as a Foreign Language) score of 500 paper base, 61 IBT, 173 computer base is required from students who are "out of country". For more information on the TOEFL please visit the **TOEFL** website. If you studied English at a Language School in the United States, we accept a TOEFL score of 460 paper base, 48 IBT. If you attended college or high school in the United States the TOEFL requirement is waived. If you studied English in your Country, the TOEFL requirement can be waived with a letter from the school or college you attended.

• IELTS Score Requirement:

An overall band score of 5.0 is required from students applying from their home country. An overall band score of 4.5 is required if the student attended and completed an English Language Training Program in the U.S. Transcripts are required from the English Training Program.

• **DUOLINGO:** Overall score of 95

Financial Statements:

Please state amount and source of support using the **Affidavit of Support** form. Also required is a letter or statement from the sponsor's bank validating that funds are available for the student's living expenses and school expenses totaling what the Affidavit of Support requires.

Your admission will be determined upon receipt of the documents listed above, we will inform you of your status by email.

Accepted

If you are **accepted** you will receive the Certificate of Eligibility (Form I-20) which is necessary for obtaining a visa from the United States Immigration and Naturalization Service for F-1 status. Note that the Form I-20 is good only for the semester(s) for which it is issued and always carries a beginning and an expiration date. The Form I-20 will be emailed or mailed directly to your home address.

Incomplete Applications

If your admission status is incomplete for current entry, you will receive an email indicating the necessary documents that will be required to complete your file for future enrollment.

Not Accepted

If your application is not accepted you will receive correspondence by email specifying the reason(s).

MEAL PROGRAM

The Meal Program is a declining balance system where students may choose any type of food offered in the Cafe. The Tiger Cafe (Cafeteria) is open when school is in session: Monday to Thursday 7:30 AM to 5:00 PM and Friday 7:30 AM to 2:30 PM

Arrival to Reedley College: Once you have arrived in the United States and at Reedley College, you will be allowed seven business days from your arrival date to make an appointment with the PDSO* or DSO** to turn in the following documents:

- 1. COPY OF PASSPORT AND VISA STAMP
- 2. COPY OF TB SKIN TEST DATED WITHIN ONE YEAR OF ARRIVAL
- 3. COPY OF HEALTH INSURANCE CARD FROM LEWERMARK STUDENT INSURANCE

The Bureau of Citizenship and Immigration Services (BCIS), an agency of the Department of Justice, is responsible for enforcing the laws regulating the admission of foreign-born persons (i.e., aliens) to the United States and for administering various immigration benefits, including the naturalization of qualified applicants for U.S. citizenship. INS also works with the Department of State, the Department of Health and Human Services and the United Nations in the admission and resettlement of refugees. BCIS is headed by a Commissioner who reports to the Attorney General.

Student and Exchange Visitor Information System (SEVIS)

Reedley College is in compliance with the regulations of the INS to report the following information to the Student and Exchange Visitor Program; name, address, country of birth, country of citizenship, date of birth, course of study, and other information about your stay at Reedley College. There is nothing you need to do to fulfill this requirement, it is taken care of by Reedley College.
