_____ **Rent Fees:** The daily rent charge is **\$18.00**. Students are required to have a summer
Initial rent payment plan on file in the Business Office no later than June 9, 2019. Students need to make the payment plan with Ralph Marrufo in the Reedley College Business Office—ralph.marrufo@reedleycollege.edu. A minimum payment of \$360.00 (Rent) must be submitted prior to arrival or when the student checks into the Residence Hall.

_____ **Tiger One I.D. Card:** Each resident is required to purchase an I.D. Card for \$10.00.
Initial This card is used as your access key to your Residence Hall room and other areas of the Residence Hall. This access card needs to be purchased at check-in. A photo of you will be taken and then placed on your Tiger One Card.

SECTION II- CONDITIONS AND TERMS:

_____ *Conditions and Terms: Please initial where indicated. Your initial indicates that you initial agree with the conditions and terms found in section II.*

A) APPLICATION PERIOD: The summer housing contract application period is May 28, 2019 through August 8, 2019. Due to limited space summer contracts are accepted on a first come first serve basis pending bed space availability.

B) LIVING REQUIREMENTS: In order to reside in the residence hall during the 2019 summer session students must be enrolled in a minimum of 1 unit. Room assignments are made by the Residence Hall Manager. Rooms are double occupancy. If available, single rooms can be requested for an additional \$18.00 per day for a total of \$36.00 per day. You may or may not be assigned the same room if you are planning to stay for the Fall 2019 semester.

C) FINANCIAL OBLIGATION: All summer rent must be paid by July 22, 2019. You must pay all financial debts from the summer session if you plan to stay in the Residence Hall during Fall 2019.

D) LIVING STANDARDS: Residents will adhere to all Residence Hall policies found in the Residence Hall Handbook 2019-2020. Residents will sign and receive a copy of a Residence Hall Handbook when they check-in. Residents will adhere to Reedley College and State Center Community College District (SCCCD) policies. All non-resident guests must sign in at each visit and purchase a summer pass for \$5.00. All non-resident guests must vacate the building by 10 p.m. Sunday through Saturday. A non-resident same gender guest may stay overnight for a fee of \$15.00 per night. Each non-resident guest may not exceed 5 nights for the entire summer. Residents are reminded that the Reedley College Campus, which the Residence Hall is a part of, is alcohol and drug free, residents found in violation of the alcohol and/or drug policy may be subject to immediate dismissal.

E) REFUND SCHEDULE-PRIOR TO OCCUPANCY: The student may cancel their Residence Hall summer contract by contacting the Residence Hall Supervisors by telephone or email prior to check-in. A cancellation penalty equal to five (5) days, \$90.00 will be charged to the Student.

F) REFUND SCHEDULE-AFTER OCCUPANCY: A 7 day notice is required should the Resident wish to be released from their summer contract for 2019. Twenty (20) days of rent (\$360.00) will be assessed as a penalty.

I have read, understand, and agree to abide by the terms of this summer contract and the rules, regulations and policies of the Residence Hall, the college and the State Center Community College District. I understand that dishonest, untrue or inaccurate information submitted on the application is grounds for immediate dismissal. I understand Reedley College reserves the right to revoke/refuse housing to applicants pursuant to established SCCC Board policies.
